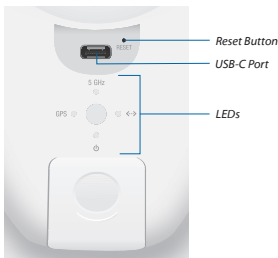


Note: For guidelines about grounding and lightning protection, follow your local electrical regulatory codes.

Hardware Overview

Back Panel



Reset Button

To reset to factory defaults, press and hold the *Reset* button for more than 10 seconds while the device is powered on.

USB-C Port

Reserved for future use.

LEDs

5 GHz The LED will light blue when the 5 GHz link is active.

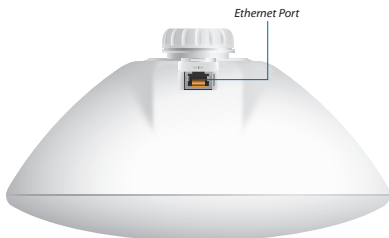
GPS The LED will light blue when the GPS signal strength is sufficient. This requires a minimum of three satellite connections.

UNMS The center LED will light when there is a connection to the Ubiquiti® Network Management System (UNMS™) server.

LAN The LED will light steady blue when an active Ethernet connection is made to the Ethernet port and flash when there is activity.

Power The LED will light blue when the device is connected to a power source.

Bottom Panel



Ethernet Port Gigabit PoE port for handling all user traffic and powering the device. Default IP address: 192.168.1.20

Pole Mounting

1. Remove the lock nut.



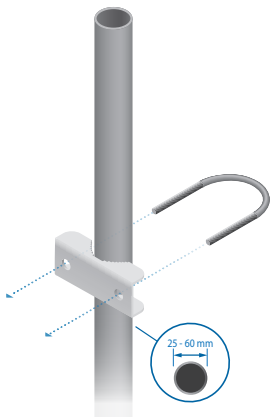
2. Attach the *Mount Bracket*.



3. Replace the lock nut.



4. Insert the *U-Bolt* into the *Pole Clamp*.



5. Insert the *U-Bolt* into the *Mount Bracket*. Secure the *U-Bolt* with the *Washers* and *Flange Nuts*.



6. Aim the device, and then lock the aim by tightening the *Flange Nuts* to a torque of 25 N·m.



Connecting Power

1. Remove the port cover by pressing down the center of the cover and sliding the cover out.



2. Connect an Ethernet cable to the Ethernet port.



3. Replace the port cover.



4. Connect the power using one of the following options:

- Using the included *Gigabit PoE Adapter*: Go to *Connecting to the PoE Adapter*.
- Using a separate PoE switch: Connect the Ethernet cable from the device's Ethernet port to a 24V Passive PoE-enabled Ethernet port on the switch.



WARNING: The switch port must comply with the power specifications listed in the *Specifications* section of this Quick Start Guide.

Connecting to the PoE Adapter

1. Connect the Ethernet cable from the device to the **POE** port of the *Gigabit PoE* adapter.
2. Connect an Ethernet cable from your LAN to the **LAN** port of the *Gigabit PoE* adapter.
3. Connect the *Power Cord* to the *Gigabit PoE* adapter. Connect the other end of the *Power Cord* to a power outlet.



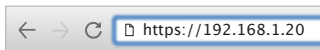
Mounting the PoE Adapter (Optional)

1. Remove the *PoE Mounting Bracket* from the adapter, place the bracket at the desired location, and mark the two holes.
2. Pre-drill the holes if necessary, and secure the bracket using two fasteners (not included).
3. Align the slots on the back of the adapter with the tabs of the *PoE Mounting Bracket*, and then slide the adapter down.

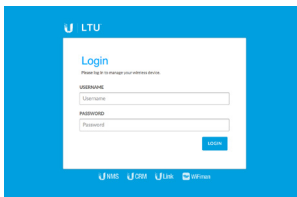


Accessing the Configuration Interface

1. Make sure that your host system is connected via Ethernet to the device.
2. Configure the Ethernet adapter on your host system with a static IP address on the 192.168.1.x subnet.
3. Launch your web browser and type **https://192.168.1.20** in the address field. Press **enter** (PC) or **return** (Mac).



4. Enter **ubnt** in the *Username* and *Password* fields. Select your *Country* and *Language*. You must agree to the *Terms of Use* to use the product. Click **Login**.



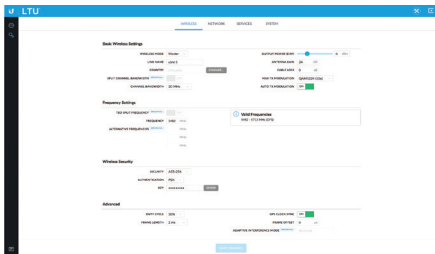

The LTU Configuration Interface will appear, allowing you to customize your settings as needed.

You can also manage your device using the Ubiquiti Network Management System. The UNMS™ app lets you configure, monitor, upgrade, and back up your devices using a single application and can be downloaded from the App Store® (iOS) or Google Play™ (Android).
